| 6. Cost: | SLAAA membership and Line Dancing activity fee |
| 7. Physical Distancing: | Required while dancing and contact must be avoided |
| 8. Face Coverings: | Not required during activity, but required at other times |
| 9. Health Screening: | Required to be completed at Front Desk |
| 10. Entries/Exits: | Separate entry and exits into space |
| 11. Onset of Illness: | Individual must be isolated to Health Rm or exit facility |
| 12. Drop-in/Spectating: | Not permitted |
| 13. Washrooms/Change rooms: | Fieldhouse change rooms or accessible washroom |
| 14. Hand Sanitization: | Frequent hand washing required |
| 15. Supply of Sanitizers: | City supplied |
| 16. Use of Equipment: | Not required |
| 17. Sanitization of Equipment: | If used, participants to do so before and after use |
| 18. Sanitization of Activity Room: | Participants to complete sanitization of touch surfaces |
| 19. Activity Waiver: | Required to be signed by participants |

Additional Notes:

- City of Stratford Return-to-Activity (C19-001) protocols must be followed, and are part and parcel of the Line Dancing Return-to-Activity Plan (C19-007)
- To avoid participants from one activity crossing with participants from another activity, participants are asked not to show up any earlier than 15 minutes before the start time of the activity to be health screened and sign in. Physical distancing will be required in all line ups
- Participants are at minimum, expected to sanitize hands and surfaces they touch before and after use
- Individual water bottles are required, and can be re-filled in change rooms
- Food and refreshments are not permitted within the activity space
- Participants must enter and exit activity space as per designated signs
- Participants are encouraged to come changed for activity
- Gathering limits will exist inside changerooms; showers not available
