| 15. Washrooms/Change rooms:          | Fieldhouse change rooms or accessible washroom            |
| 16. Hand Sanitization:               | Frequent hand washing required                            |
| 17. Supply of Sanitizers:            | City supplied   |
| 18. Use of Equipment:                | Permitted   |
| 19. Sanitization of Equipment:       | Participants to do so before, during and after use        |
| 20. Sanitization of Activity Room:   | City to complete  |
| 21. Activity Waiver:                 | Required to be signed by participants                     |

**Additional Notes:**

- City of Stratford Return-to-Activity (C19-001) protocols must be followed, and are part and parcel of the Lapidary Return-to-Activity Plan (C19-003)
- Participants are at minimum, expected to sanitize hands and touch surfaces before and after use
- Individual water bottles are required
- Food and other refreshments other than water are not permitted within the activity space
- Lapidary to schedule regular maintenance of equipment
- Use of grinder room requires two persons, for health and safety reasons
