NOTICE OF NOISE BY-LAW EXEMPTION

An exemption from Noise Control By-law 113-79 was approved for the following events:

1. Rotary Club Dragon Boat Festival for the unreasonable noise provision for the duration of the event on Saturday, September 16, 2017 on Lakeside Drive from Front Street to Lakeside Drive North.
2. Stratford Fall Fair until 11:00 p.m. each evening from Thursday, September 21 to Saturday, September 23, 2017 inclusive and until 4:00 p.m. on Sunday, September 24, 2017 and from the unreasonable noise provision for the duration of the event including set up and take down from September 18 to 25, 2017 inclusive.
3. Canadian Cancer Society Neon Night at 72 Water Street on Friday, September 22, 2017 from 7:00 p.m. to 10:00 p.m. from the loading and unloading provision and from the unreasonable noise provision.
